Item 3. APPROVAL OF MINUTES

Item 4. BUSINESS REPORT

Mr. Zoellner distributed the October Financial report and discussed the switch to Horizon Bank.

Motion to approve the 10 year loan with Horizon Bank. The resolution passed unanimously upon a motion by Ms. Mitchell, seconded by Ms. Carrizales-Alonzo. (7-0)

Item 5. ADMINISTRATION REPORT

Mr. Donnelly was thrilled to share the success of Black River's Varsity Boys Soccer team who were named this year's regional champions. He was also able to attend a recent professional development with GVSU's Charter Schools Office and greatly appreciated the one on one experience.

Mr. Brunink turned things over to the Green Team for a presentation on composting. Hailey Huggett, Hannah Huggett, Molly Huggett, and Nolan Meier each shared the benefits of composting, results of a waste audit for Black River's campus, and addressed obstacles/concerns that are anticipated in the implementation of this program.

Mr. Brunink indicated that Covid has continued to be a focal point. BR has experienced an uptick in cases but is not considered an outbreak at this time. He outlined Ottawa County's data and explained how this has resulted in staffing shortages. The county's mask mandate will lift on January 2nd and schools will then implement masking requirements individually. Mr. Brunink has asked Dr. Stephanie Grant to present about trauma tied to Covid-19 and the need for self care at the November 23 professional development. Elementary will also focus on Right Start Math.

Mr. Brunink also reiterated the accomplishments of the Varsity Boys Soccer team sharing how impressed he was with their discipline and ability to handle adversity. He also shared that the BR Theatre Company had a wonderful performance of Clue.

Mr. Brunink indicated that they are working to schedule the next Finance Committee meeting. Mr. Davis shared that he greatly appreciated the efficiency of virtual parent teacher conferences. And Ms. Carrizales-Alonzo noted that teacher wishlists could be posted virtually if done again.
